## **PRESS RELEASE: 7/10/18 Heroin -Related Arrests by Drug Task Force**

July 12, 2018

On July 10, 2018, the Franklin County Drug Task Force (“FCDTF”) executed a search warrant at 102 South Federal Street in Chambersburg, following a drug trafficking investigation in Chambersburg.

Upon execution of the search warrant, three suspects of the investigation, Demetrius Terrance Faust, Tyler Stone Herrington and Khory Omahr White, were found inside the residence.

A search was conducted, which yielded amounts of crack cocaine and heroin in quantities and packaging consistent with the distribution of controlled substances. Drug paraphernalia was also seized from the residence consistent with the distribution of controlled substances. Two handguns were seized from the home during the search.

All three suspects were arrested for felony drug crimes and taken to the Franklin County Booking Center. They were later arraigned and jailed on \$250,000 bail by Magisterial District Judge Duane Cunningham.

The FCDTF, Pennsylvania State Police Troop H Vice, Pennsylvania State Police Chambersburg, Chambersburg Police Department, and the Washington Township Police Department assisted with the investigation and the search warrant.
