**PRESS RELEASE: HEROIN/FENTANYL-RELATED ARREST BY FRANKLIN COUNTY
DRUG TASK FORCE (“FCDTF”)**

On September 4, 2018 the Franklin County Drug Task Force conducted an investigation that led to the arrest of Glenn Wolfe, no fixed address, for felony drug crimes related to the distribution of heroin/fentanyl in the Waynesboro/Washington Township areas.

Wolfe was arrested at 13030 Washington Township Blvd. in Washington Township after surveillance captured Wolfe conducting drug sales at that location. Upon being taken into custody, Wolfe was found to be in possession of additional quantities of suspected fentanyl, a digital scale, a quantity of US currency and drug paraphernalia. A quantity of methadone pills were located in the vehicle that Wolfe had occupied to which Wolfe admitted belonged to him. Wolfe also admitted to investigators that he was a distributor of fentanyl and heroin in the Waynesboro/Washington Township areas.

Wolfe was arrested and charged with one count of unlawful delivery of a controlled substance and two counts of possession with intent to deliver a controlled substance, arraigned and jailed on \$300,000 bail.

Detectives from the Waynesboro and Washington Township Police Departments were the lead investigators in this case. Patrol units from both departments also assisted along with members of the FCDTF.
