SEARCH WARRANT EXECUTION AT 844 RAYSTOWN CIRCLE, SOUTHAMPTON TOWNSHIP

At approximately 8:30 P.M. on 7/13/2016, the Franklin County Drug Task Force executed a search warrant at the residence of Jahleel Antonio Aviles-Charloteen, 844 Raystown Circle, in Southampton Township. The search warrant was obtained as part of an ongoing investigation into the distribution of heroin in the Shippensburg area.


During the search of the residence, investigators found thirty-three bags of heroin, a digital scale, multiple cellular telephones, packaging materials, and a quantity of United States currency inside the bedroom of Aviles-Charloteen. A random sample of the suspected heroin was field-tested and yielded a positive presumptive reaction for the presence of heroin.

Aviles-Charloteen was charged with Possession With Intent to Deliver a Controlled Substance. He was arraigned by District Justice Cunningham and committed to the Franklin County Jail in lieu of \$150,000 bond. His preliminary hearing has been scheduled for 7/26/2016, at Franklin County Central Court.
