PRESS RELEASE: SEARCH WARRANT EXECUTION AT 3208 LINCOLN WAY EAST, GUILFORD TOWNSHIP

At approximately 0605 hours on 7/15/2016, the Franklin County Drug Task Force and the Pennsylvania State Police Special Emergency Response Team (SERT) executed a search warrant at a residence located at 3208 Lincoln Way East, in Guilford Township. The search warrant was obtained as part of an ongoing investigation into the distribution of heroin by a subject known as "Marcus," subsequently identified as Marcus Longus, in Washington County, MD and Franklin County.

During the search of the residence, investigators found approximately 25 grams of heroin, 16 individually packaged bags of marijuana, approximately 150 grams of cocaine, digital scales, multiple cellular telephones, packaging materials, U.S. currency, and a handgun inside the bedroom of Longus.

Longus was charged with 3 counts of Possession With Intent to Deliver a Controlled Substance. He was arraigned by Magisterial District Judge Kelly Rock and committed to the Franklin County Jail in lieu of \$75,000 bond. His preliminary hearing has been scheduled for 7/19/2016, at Franklin County Central Court.
