Document Service via Deputizing another county

If deputizing to serve another county only - \$42.00 **plus \$19.00 for each additional address/defendant

If serving in Franklin Cty and deputizing another county–Use the fee chart above for the **location fee, plus \$19.00 for each additional address/defendant **and \$9.00** to deputize.

Please provide a check payable to the other county for their fees in addition to your check for Franklin County

Document Service via Certified Mail

If serving certified mail only - \$42.00 **plus \$19.00 for each additional address/defendant

If serving in Franklin Cty and by certified mail – Use the fee chart above for the **location fee, plus \$19.00 for each additional address/defendant **and \$9.00** postage.

Writs of Execution - possession, seizure, personal property and bank attachments require a flat deposit of \$250.00 for which fees will be taken and any difference refunded.

Writs of Execution - real estate require a flat deposit of \$2,000.00 for which fees will be taken and any difference refunded.
