- Two Seraphin 5 gallon provers and a small cart to move them around. Ten good 50 lb. weights. Ten older rusted 50 lb. weights. Three 25 lb. weights.

Barn Beams from Franklin Farm Lane barn

- The beams consist of horizontal and vertical structural barn beams.
- Most of the beams are original hand hewn white oak beams. A few replacements over the years have been made. These beams are machine cut.
- Several of the beams are pine - most likely Hemlock
- The length of the beams vary and are in single log form or segmented in length. Some beams are nearly 55 feet in length
- The structural members supporting the barn floor beams/joists are segmented and larger dimensionally. Some beams are up to 20 feet in length. Others are 12 - 16 feet or so in length. Most are original hand hewn beams.
- A small percentage of the beams reflect burn damage from the fire in 1975
- Older methods of joining structural beams together reflecting the drill and wood pin method still remain. Other joints are fastened with large 24 penny or larger common nails
- The upper level barn floor boards remain. The thickness of the boards range from 4/4 to 7/4. Some boards are original and in tact.
- Many of the original square head cut nails still remain in the floor boards.
- The farm on Franklin Farm Lane, years ago, had mature white oak timber growth and during construction of the barn in 1879 it is very likely the structural beams were cut from the white oak on the farm.
- All wood (floor boards, horizontal and vertical beams, gates, lower loafing stall troughs, timbers, boards, etc.) are to be removed in their entirety from Franklin County barn property
- Access and temporary staging is available for truck, lift equipment, dumpster containers, etc. on site
- Upon completion of work only broom clean-up material may remain on site
- The successful bidder will be required to sign a waiver and release and provide evidence of acceptable insurance as required by Franklin County. Bidder removes the wood/beams at their own risk. The County is not responsible for bodily injury or property damage arising from their activities

BID SHEET

- Removal of the barn beams is not to interfere with County, PSU Ag. Ext. or related Ag. Ext. daily business
- Removal of the barn beams is not to obstruct access onto or leaving the property at any time
- Removal of the barn beams is not to obstruct or prevent access of emergency vehicles or responders at any time
- Removal of the barn beams may proceed from 7:00am to 8:00pm Monday through Saturday
