10/9/14 Service of Arrest and Search Warrants

At approximately 0600 hours on 10/09/2014, officers from several area law enforcement agencies began serving arrest warrants at various locations throughout Franklin County. The arrests were the result of the collaborative investigative efforts of the Chambersburg Borough Police Department, the Pennsylvania State Police, and the Franklin County District Attorney's Office, all of whom comprise the Franklin County Drug Task Force. The investigations that resulted in these arrests focused primarily on street and mid-level heroin and prescription medication trafficking and began late last year. The investigation consisted of a series of controlled purchases made by undercover officers and confidential informants, as well as physical and electronic surveillance.

The majority of controlled purchases took place in Chambersburg, Fayetteville, Greencastle, and surrounding municipalities.

10 individuals were arrested during last Thursday's sweep and additional arrests are anticipated.

Also, at approximately 0700 hours on 10/9/14, a search warrant was executed at 7115 Brownsville Road, in Greene Township. The search warrant was the result of an investigation into the distribution of heroin occurring at the residence. During the search of this residence, officers recovered approximately \$3,750 worth of heroin, \$350 worth of crack cocaine, and 3 firearms, each of which had been reported stolen. Rocky Lamar Lindsey, 42 YOA, Brooklyn, NY, was charged with one count of Possession With Intent to Deliver a Controlled Substance as a result of this incident. Charges of Possession with Intent to Deliver a Controlled Substance are also pending against 3 other people as a result of this incident.

At approximately 1430 hours on 10/9/14, another search warrant was executed at 938 Byers Ave., in the Borough of Chambersburg. This warrant was the result of an investigation into heroin distribution from

this residence. Officers recovered approximately \$1,000 worth of crack cocaine and \$1,600 worth of heroin during the execution of the search warrant. Charges are pending against one person as a result of this incident.

Agencies participating in the arrests include the Shippensburg Borough Police Department, the Mercersburg Borough Police Department, the Chambersburg Borough Police Department, the Pennsylvania State Police, the Franklin County District Attorney's Office, and the Federal Bureau of Investigation.

The factual information described above is contained within a public record, specifically the Criminal Complaint/Affidavit of Probable Cause filed in this matter.


