

NOTICE OF PUBLIC HEARING ON THE MODIFICATIONS OF THE COUNTY'S FY 2016 AND FY 2017 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAMS

Notice is hereby given that the Franklin County Planning Department will conduct a Public Hearing on Wednesday, September 22nd, 2021 immediately following the Commissioners Meeting starting at 11:00 AM prevailing time at the Franklin County Administration Building Board Room, 272 N. Second Street, Chambersburg, PA. The purpose of the hearing is to obtain citizen views and comments on the modifications of the County's FY 2016 and FY 2017 CDBG programs. This meeting is accessible to individuals with disabilities and/or for persons with Limited English Proficiency. The proposed modifications for the FY 2016 and FY 2017 CDBG projects are as follows:

A. FY 2016 CDBG Program:

1. **Borough of Greencastle - ADA Curb Ramp project:** The project has been adjusted in scope and funding amount. Budget reduced from \$55,260.00 to \$49,204.73
2. **Quincy Township - Tomstown Water Main Line Extension:** The project was completed under budget and remaining funds will be re-allocated to Greencastle Boroughs FY 2017 S. Jefferson Street project. Remaining funds total \$22,566.58
3. **Quincy Township - Water Lateral Assistance:** The project was completed under budget and remaining funds will be re-allocated to Greencastle Boroughs FY 2017 S. Jefferson Street project. Remaining funds total \$4,370.15

B. FY 2017 CDBG Program:

1. **Borough of Greencastle - S. Jefferson Street:** The project has not changed in scope, but requires an adjustment in funding amount. This is necessary due to the difference in the estimated construction costs from 2017 to now completing the project in 2021. Additionally, the project will be changed to a multi-year project and will utilize the remaining funds from 2016. Total project cost will increase to \$261,038.00
2. **PathStone - Homeownership Program:** This project is no longer being completed. Available funds will be re-allocated to Greencastle Boroughs FY 2017 S. Jefferson Street project. \$25,800.00 in funds was re-allocated.
3. **Quincy Township - Mentzer Gap Road Public Water Main Line Extension:** This portion of the project cannot be completed within the required timeframe. Available funds will be re-allocated to Greencastle Boroughs FY 2017 S. Jefferson Street project and the remaining multi-year project will be adjusted to account for this change. \$62,594.00 in funds was re-allocated.

None of the above listed and described activities are expected to result in displacement. Modification documents are available upon request.

All interested citizens are encouraged to attend and will be afforded the opportunity to give oral testimony and/or to present written comments concerning the modifications. The deadline to receive
